Joyce Sonday:

10700 120th Avenue, Pleasant Prairie, Wisconsin. Couple things – as you know, I have two properties. They took 18 and 24. Parcel 18 was my Sonday's Vans and 24 is where my military museum is. My Sonday's Vans is gone. It is out. It is gone. I am still owed \$12,000 from Sonday's Vans. I would like to know where that money is. I have been told by the Department of Commerce that if I don't have the money by Monday to start an appeal process. The check has been cut. I don't know if Jim Machnik has it or Karen Wood has it. I don't know if Del Detman or Mike have it. I do not know where it is at. So if I don't have the \$12,000 check for my Sonday's Vans so I can continue to do my business – I need to know where the check is at. Sonday's Vans has been out since April of last year.

Second of all, Wednesday of last week, the CDA or one of the lawyers for the Village, Katie was over, and they hired someone because they are upset with the prices I have got to move my equipment. The first thing I told you people back in August of 2002 do you understand what I have out there, how much it is going to cost to move? And Jim Machnik, who is not here, said yes, we have moved printing presses and I said fine. Now we have estimates of \$1.2 million to move my equipment and it was your people, Aetna Moving, they were someone that Jim Machnik gave us his number and now they are telling us it is our guys and I would just like to know if this Big Red who came out Wednesday has given you guys an estimate of what it is going to cost. We want to get on with our lives. It is really getting irritating that nothing is getting done. We want to be out at a new location by Memorial Day because Memorial Day to Labor Day is my busy time out there. I don't know if you have ever been out there to my museum. I know Mike was out there and he had a good time and I know he did. We had an open house there and he was there. I do 20,000-30,000 people a year out there during that couple of months. I am not going to close between Memorial Day and Labor Day. So if we don't have a new place – and then today I am reading the paper and they brought up the Tri-Clover. Now that place is out. I am not moving my museum to Tri-Clover - we already discussed it, I cannot afford it. If we need to go to litigation with it, I will. There is no traffic. I cannot afford \$400,000 a year rent. Just the rent is \$400,000 year. We have already found a new location. I Community Development Authority January 25, 2006

don't know if you have been aware of it. I know it is going to cost a lot to move us there but that is what Racine County is asking us to do. We want to get on with our lives just as much as you want my property. We are not stalling it, you people are stalling it. We have been ready to move. We have estimates, we have everything you guys have asked for and it is just sitting still and doing nothing. I just would like to know what is going on and let's get on the road.

There was a check that was set by the Authority and it was given to HNTB. We have also had an issue that the Authority has not received any rent since we acquired the property. I think those are issues that need to be resolved.

The \$12,000 was for It has nothing to do . . . my Sonday's Vans is out of there. There are two separate entities. Sonday's Vans and the Military Museum are two separate businesses.
