#### Mike Pollocoff:

No. It's a nice name, it's got a nice ring to it, but we couldn't verify that or substantiate it. As Kris comments that we had six comments and four supporters, and there were more people that didn't identify. They left anonymous. There was more than that on the Brookside Gardens one.

I kind of like Brookside Gardens.

## Kris Keckler:

That's what I was thinking of.

## Troy Holm:

That's my choice.

# Michealene Day:

Okay, can I have a motion then to -- well, we have a choice Brookside Park, Brookside Gardens Park or Brookside Gardens Community Park. Now, it wouldn't be a community park, correct, it would just be a neighborhood park.

## Mike Pollocoff:

Neighborhood park.

Kris Keckler moved to recommend the name of the newest Village neighborhood park, Brookside Gardens Park, to the Village Board of Trustees: Seconded by Cindy Schwab. Motion carried 5-0.

It will happen. This has got to go to the Board. The Board has to make the official designation, but we'll give them your recommendation.

Jim Bandura moved to elect Troy Holm for Park Commission Secretary: Seconded by Kris Kecker. Motion carried 5-0.

Thanks.

Welcome. And then Secretary. Anyone have any ideas or would like to? Cindy?
Cindy Schwab:
What do they do?
Michealene Day:
Basically if there is a resolution that is passed the Chairperson and then the Secretary sign for it. If Mike had said that there's some reason that we've been really bad and we had to go to court you'd have to sit next to me.
Cindy Schwab:
Yeah, I can do that but I hope I don't have to go to court.
Jim Bandura:
I would recommend Cindy being Secretary.
Kris Keckler:
Second.
Jim Bandura moved to elect Cindy Schwab as Park Commission Secretary: Seconded by Kris Kecker. Motion carried 5-0.
