

NOTICE OF PUBLIC HEARING CONTINUATION ON SPECIAL ASSESSMENTS CTH "H" AND 70TH STREET WATER MAIN EXTENSION

PLEASE TAKE NOTICE that the Village Board of the Village of Pleasant Prairie, Kenosha County, Wisconsin has adopted a preliminary resolution (#20-03) declaring its intention to exercise its police power to levy special assessments pursuant to section 66.0703, Wis. Stats., upon property within the proposed assessment district which is generally bounded by properties fronting 88th Avenue (CTH "H") from 74th Street extending north to the Village jurisdictional boundary and properties fronting 70th Street, from 88th Avenue, extending west to 89th Avenue, in the Village of Pleasant Prairie. The project generally consists of: 1) 12-inch water main and appurtenances along CTH "H" beginning approximately 150-feet north of 74th Street and extending north approximately 2,100-feet and 2) 8-inch water main and appurtenances along 70th Street beginning at CTH "H" and extending west approximately 400-feet.

Upon due notice as described in Wisconsin Statute Section 66.0703(7), the Village Board held a public hearing virtually on the internet utilizing a web-based application called GoToWebinar on August 3rd, 2020 at 6:00 p.m. for the purpose of hearing all interested persons concerning the preliminary resolution and the report relating to the proposed improvements and assessments, and heard all persons who desired to comment at the hearing.

Following the August 3rd public hearing, at the direction of the Village Board, Village staff further considered the matter in light of issues raised which resulted in modifications being made to the proposed interest charges for installment payments; and the matter is hereby being re-noticed for further hearing as described in Wisconsin Statute Section 66.0703(7). You are further notified that the Governing body will hear all interested persons, or their agents or attorneys, concerning the report related to the revision to the proposed interest charges and assessments at 5:00 p.m. on the 21st day of September, 2020. The public hearing will be conducted virtually on the internet utilizing a web-based application called GoToWebinar. This will be the last meeting held concerning the project special assessment. All objections will be considered at this hearing and thereafter the amount of the assessments will be finally determined.

There will be an opportunity for the public comment during the session. To access the virtual meeting, register in advance online at PleasantPrairieWi.gov/MainExtension for the 9/21/2020 Village Board meeting. Once registered, you will receive log in instructions via email. The night of the meeting registered users will need to follow emailed login instructions to access the virtual meeting. Users that utilize this method will have an opportunity to raise a virtual hand to speak during the public comment portion of the meeting. to engineering@plprairie.com mailed or placed ahead of time in the Village Hall drop-box at 9915 39th Avenue. All comments received before noon on September 21, 2020 will be distributed to the board and considered at the meeting. The last option is to attend in person a virtual site at the Village Hall Auditorium. Please note Village Board and Committee members will not be present at Village Hall, and will participate in the meeting virtually. In-person attendance is not recommended due to concerns surrounding COVID-19 but those wishing to attend this virtual site at Village Hall, please RSVP by calling (262) 925.6729.
