

## NOTICE OF PUBLIC HEARING ON SPECIAL ASSESSMENTS BEVERLY WOODS STORM WATER IMPROVEMENT PROJECT

**PLEASE TAKE NOTICE** that the Village Board of the Village of Pleasant Prairie, Kenosha County, Wisconsin has adopted a Preliminary Resolution (#21-01) declaring its intention to exercise its police power to levy special assessments pursuant to §66.0703, Wis. Stats., upon property within the proposed assessment district which is generally bounded by 85<sup>th</sup> Street to the south, Cooper Road to the west, 83<sup>rd</sup> Street to the north, and 43<sup>rd</sup> Avenue to the east for benefits conferred upon the property for the construction of storm water improvements within the Beverly Woods Subdivision in the Village of Pleasant Prairie.

A report of the estimated cost of improvements and schedule of proposed assessments are on file at the Office of the Village Engineer, Pleasant Prairie Village Hall, 9915 39th Avenue and may be inspected by appointment at (262) 925.6729 or may be inspected on the Village's website at <a href="PleasantPrairieWi.gov/MainExtension">PleasantPrairieWi.gov/MainExtension</a>

PLEASE TAKE FURTHER NOTICE that the Governing body will hear all interested persons, or their agents or attorneys, concerning matters contained in the preliminary resolution authorizing the assessments and the above described report at 6:00 PM on the 15<sup>th</sup> day of March 2021. The public hearing will be conducted virtually on the internet utilizing a web-based application called GoToWebinar. The hearing will be held during the Village Board meeting which starts at 5:00 PM, however, the hearing will not start until 6:00 PM. This meeting will be the last meeting held concerning the project special assessment. All objections will be considered and thereafter the amount of the assessments will be determined.

There will be an opportunity at the public hearing for public comment. To register for the virtual meeting, go to <a href="PleasantPrairieWi.gov/GoTo">PleasantPrairieWi.gov/GoTo</a>. Once registered, login instructions on how to access the web-based virtual meeting scheduled for March15, 2021 will be emailed. Users that utilize this method will have an opportunity to raise a virtual hand to speak during the public comment section. Written comments received before noon on March 15, 2021, will be distributed to the Village Board and considered at the public hearing. The last option is to attend in-person at the Village Hall Auditorium. Please note that Village Board members will not be in-person and will be participating in the public hearing virtually. In-person attendance is not recommended due COVID-19 safety concerns. Any person wishing to attend in-person must RSVP by calling (262) 925.6729.
