# **Plans to Acquire Land for Park Expansion**



The Village is taking steps toward expanding Pleasant Prairie Park, located at Bain Station Road and 104th Avenue. In June, David Gentz approached Village staff and expressed interest in selling three family-owned parcels abutting Pleasant Prairie Park's west end. The land is east of 108th Avenue and north of 84th Street.

The land acquisition supports the Pleasant Prairie Park expansion outlined in the 2018 Park and Open Space Plan. The property is mostly undeveloped with one single-family home.

Gentz supplied a letter to the Village asking \$425,000 for three tax parcels, 91-4-122-074-0390, 91-4-122-074-0395, and 91-122-074-0400. The combined size of the three properties totals approximately 4.4-acres.

The Village Board approved the land purchase during their October 5 meeting. Funds for the investment created an unexpected expense that was not included in the Village budget for 2020. The Village added the parkland's purchase to the General Obligation Resolution, approved earlier in the meeting, to accommodate the acquisition and will use Park Impact Fee reserves for future park improvements.

Pleasant Prairie Park is currently a 22-acre community park. With the new property purchase, the park will expand to 26.4-acres and connect to 108th Avenue. Presently, the park offers a youth soccer

field, restrooms, two playground areas, open green space for passive recreational activities, basketball hoops, tennis courts, and two parking areas. Plans for the expansion propose including additional parking and a disc golf course.

The original concept plan for Pleasant Prairie Park was created in 2006 as part of the first Village Park and Open Space Plan. Every five years, Village staff updates and refines the plan based on changes in the community. This process enables the Village to remain qualified for certification from the Wisconsin Department of Natural Resources and therefore maintain eligibility to qualify for matching grant funding through the Federal Land and Water Conservation Fund and the PLEASANT Wisconsin Stewardship PRAIRIE Fund.

# Tax Incremental District No. 8 Boundaries Established

The Plan Commission, on September 14, approved a resolution designating the boundaries of Tax Incremental District (TID) No. 8 in the Village of Pleasant Prairie. The new district consists of 130 parcels, totaling 127 acres of land, generally located south of Highway 50, between 104th and 115th Avenues.

The creation of TID 8 is necessary to accommodate the mixeduse, multi-phase developments planned for the district. Fiduciary Real Estate Development is the developer proposing this project and requesting TID financial support.



The total improvement cost attributed to the TID is estimated to be around \$12 million, including design, construction, and administration. Proposed public infrastructure improvements include completing 77th Street, 109th and 115th Avenues, stormwater management, utility installations, and other eligible project costs. The Village staff is currently working with the developer to finalize the Project Plan and Development Agreement.

The Village Board, on February 3, approved a Conceptual Plan for 300 upscale apartments. The developer intends to begin construction in 2021 on the approximately 29-acre multifamily apartment project, known as Seasons at River View. This development is the first phase planned for TID 8. The proposed remaining stages for TID 8 consist of two commercial development sites and a senior housing complex.

The approval process to create the Tax Incremental Financing District for TID 8 is being completed in three phases. The Tax Incremental District requires approval from the Joint Review Board (JRB), Plan Commission, and Village Board. □

# **HARIBO Extends Building Permits**

On October 12, the Plan Commission approved HARIBO's request to extend the Master Conceptual Plan and Final Site and Operational Plan Building Permits for its Pleasant Prairie manufacturing plant. The extension is a precautionary measure added due to the overlap of expiration dates, the time needed for the State's approval process, and the challenges posed this year due to COVID-19.

The previous Master Conceptual Plan was expiring November 7, 2020, and the Final Site and Operational Plan was expiring November 11, 2020. While having the extension, HARIBO still intends to meet the deadlines by submitting Final Plans to the Village Board and filing for permits in November. The project is progressing; HARIBO recently announced Gilbane Building Company is the development's general contractor and stated the new facility involves an investment well above \$300 million.

Due to the tight time frame, Village staff determined it was best to extend the expiration dates out of caution to allow more time to obtain State approvals. HARIBO has already received conditional approval from the State of Wisconsin for the production building and is working with the State to obtain conditional consent for its warehouse.

"We're working closely with the Village of Pleasant Prairie and the State of Wisconsin as we're making great progress to move forward with our U.S. factory, and to do this during our 100 Year Anniversary is something special," said Arndt Ruesges, Chief Production Officer, HARIBO of America. "All along we've said we want to build a top-quality facility that is woven into the fabric of the community, and as we're taking these next important steps we're closer to bringing that to life."

"HARIBO is a great partner and a pivotal addition to Prairie
Highlands Corporate Park," said Nathan Thiel, Village
Administrator. "The project reflects a large investment in

the community that will create jobs and benefit the local economy. Pleasant Prairie looks forward to seeing this highly anticipated development take shape."

The Pleasant Prairie facility will be HARIBO's first-ever North American plant. The campus development is planned to be completed in phases on 136.8 acres of property located at the southwest corner of 122nd Avenue (West Frontage Road) and CTH C (Wilmot Road) in the Prairie Highlands Corporate Park. □

# **General Government Budget**

On November 2, Village staff presented the proposed 2021 General Government Budget to the Village Board. The budget proposes raising the tax levy from \$12,652,261 in 2020 to \$13,296,940 for 2021, an increase of \$644,679. The levy change will have a small impact on the property tax bill. An average home in the Village valued at \$237,200 will translate to a \$9.64 increase in the Village portion of the tax bill.

The funds will cover Village services such as fire and rescue, police, community development, road improvements, and snow plowing. The proposed 2021 budget includes inflationary increases across most departments, but no new positions or additional programs are being added. Proposed capital purchases include road improvements of \$2.3 million, replacing two fire engines with a quint engine, Pleasant Prairie Park Improvements, designing a new law enforcement facility, replacing police vehicles, and land acquisitions for the Highway 50 reconstruction project.

The Village will also consider an additional tax levy of \$1.5 million to assist RecPlex with the facility's \$2.5 million annual debt service payment. The RecPlex was the hardest-hit Village-owned entity in 2020 due to COVID-19. Since October 2000, when the Village initially issued General Obligation debt to construct the comprehensive workout center, the RecPlex has remained self-sufficient with its revenues. For the first time in 20 years, the sports complex requires Village tax dollar assistance due to the pandemic. Adding the RecPlex debt to the levy would result in another \$119.65 increase for the median-valued home. The total Village portion of the property tax payment would increase from \$1,051 in 2020 to \$1,180 in 2021.

A public hearing for the 2021 General Government budget is planned for Monday, November 30, at 5:00 p.m. The hearing will be held virtually; visit *PleasantPrairiewi.gov/Goto* to register.



# **COVID-19 Effect on RecPlex Operations**



State and County health mandates surrounding COVID-19 restricted the RecPlex facility's use over the past six months in terms of occupancy and spectators. The complex was mandated to close operations for ten consecutive weeks. Orders limited the ability to recruit new members and encouraged membership cancellations, resulting in an estimated revenue loss of \$3.6 million. RecPlex staff established proactive measures to handle revenue loss, reducing operating expenses by \$1 million, and utilizing \$1.6 million of \$2 million in cash reserves. Despite countless staff hours spent petitioning for assistance, the RecPlex did not qualify for any State and Federal relief aid because it is municipal-owned. The Village redirected over \$1 million as an inter-fund loan to help cover the RecPlex's debt.

Projections for RecPlex in 2021 estimate a \$1.8 million revenue loss. RecPlex plans to continue the facility's expense reductions and salary attrition to reduce cost by an additional \$250,000. The 2021 RecPlex budget covers all operation costs and debt interest. Over \$300,000 in planned capital improvements are being placed on hold. Proposed tax levy funds will cover \$1.5 million of debt principal. To compensate for the Village tax dollar support, RecPlex plans to offer Pleasant Prairie taxpaying households five guest passes to use the facility, free Lake Andrea beach access, and a free parking pass with a RecPlex membership.

"For its 20th anniversary, 2020 should have been all celebration for the RecPlex," said Nathan Thiel, Village Administrator. "Despite this year's struggles, I am confident the Village will come together to support this incredible community asset."

RecPlex is the largest municipal-owned recreational facility in North America; it has a significant economic impact on the region. Conservatively, in 2019, RecPlex events brought \$7.18 million into the community. The complex is used by many area businesses as a recruitment tool, serving corporate fitness programs and family services. RecPlex also provides childcare and therapeutic recreation for residents and offers over 200 jobs to the community.

# **2021** Solid Waste Utility Budget



#### What Is Solid Waste Utility?

The Solid Waste Utility provides curbside garbage, recycling, and leaf collection for approximately 7,540 homes. The utility also operates the Residential Recycling Center (RRC). It offers hazardous waste collection the first Saturday of each month, along with free compost, mulch, shred events, and Christmas tree drop-off sites.

#### **What to Expect During 2021?**

As part of the 2021 Solid Waste Budget, the Village plans to continue all services, including the new billable service offered in 2020 that picks up brush and branches from resident homes. The types of items collected at the RRC will remain the same. Some changes to the Village's costs in 2021 includes a higher volume of waste being collected at slightly higher tipping fees and an increase in hours needed to collect recycling, garbage, and leaves. A monthly \$2.00 rate increase is being proposed to cover the increased costs for the services offered. Unlimited volumes of recycling and household hazardous waste can still be dropped off at no additional charge.

# **2021 Clean Water Utility Budget**

#### What is the Clean Water Utility?

The Clean Water Utility, operating since 2006, was created to protect lakes, streams, rivers, and groundwater from contaminated stormwater runoff. Federal mandates require municipalities to improve stormwater quality. Stormwater comes from rain or melting snow that collects contaminants and transports them through the storm sewer and into local waterways. The Public Works department's efforts reduce pollutants and keep the waterways clean.



The maintenance and replacement of existing stormwater infrastructures are both funded by the Clean Water Utility. New stormwater projects that improve drainage in specific areas are funded by the affected property owners. The Village collects a stormwater fee from property owners based on how a property generates stormwater runoff.

All properties contribute to stormwater runoff in varying degrees based on soil type, surface, and property use. Funds collected by the stormwater fee are used to pay for the maintenance of Village-owned stormwater infrastructures, maintaining catch basins, and preserving natural drainage systems like streams and buffers. Infrastructure supported by the Clean Water Utility is valued at more than \$27.1 million dollars.

#### What to Expect During 2021?

The Clean Water Utility will continue to perform street sweeping, outfall inspections, and catch basin cleaning. The Village is considering one new infrastructure stormwater improvement project for 2021 in Beverly Woods. There is also a \$1 per Equivalent Runoff Unit (ERU) increase proposed for 2021.

# **Police Department Joins Ring Neighbors**



The Pleasant Prairie Police Department has joined Ring Neighbors. This network that allows residents to share safety concerns about local crime with the community. With the Neighbors app, users can post videos captured from cameras, distribute photos, post text, and receive real-time safety alerts.

"There are numerous Ring cameras in our community, and we understand the value those cameras can provide during investigations," said Dave Smetana, Police Chief. "Being able to reach out on the Neighbors app when there is a crime or incident and ask the community to share footage and information is incredible. The technology allows public safety agencies to create safer communities by connecting with residents in a new way."

Residents do not need a Ring device to join Neighbors. Anyone can participate by downloading the Neighbors app to their smartphone. Devices with the app can receive updates and post photos, text, or videos. All posts are anonymous, and a user's name or address will only be shown if a user chooses to display it.

The Neighbors app works in tandem with the Community Camera Partnership. The ongoing crime-fighting partnership with Village residents enables residents to share video footage from home security cameras if a crime or suspicious activity occurs. The two platforms are modern-day extensions of the Neighborhood Watch Program. All aspects of these programs are entirely voluntary. Police would not have remote access to security systems or Ring devices. The homeowner remains in complete control of their camera systems. □

# **Police Officers Awarded for Their Courageous Actions**

Pleasant Prairie Police and Fire & Rescue units responded to a house fire in the 8300 block of Old Green Bay Road on September 28. As the Police officers arrived, they were advised that an individual was trapped on the second floor. Officer Jeremiah Gates and Sergeant Derek Andrews entered the structure to attempt a rescue; however, they could not locate the trapped individual due to intense smoke. Lieutenant Pete Jung joined the officers' efforts. All three officers entered the burning structure several times and found the fire victim in a second-floor bedroom. The officers worked as a team to remove the individual who had succumbed to injuries due to the fire.

On October 7, all three officers were awarded written commendations and department challenge coins for their courageous actions. Each officer demonstrated extreme bravery and dedication to their profession and community.

# Did you know?



Thanksgiving is the leading day for home fires involving cooking equipment.

Keeping fire safety top of mind in the kitchen during the holidays is essential, especially when there are many activities and people. While preparing a holiday schedule to organize a large family feast, remember to follow these simple safety tips to help keep yourself and your family safe from fire:

- Stay in the kitchen when you are cooking, so you can keep an eye on the food, and stay home when cooking your turkey so that you can check on it frequently.

- Keep knives out of the reach of children.
- Never leave children alone in a room with a lit candle.
- Keep the floor clear so you don't trip over kids, toys, pocketbooks, or bags.

# **Twelfth Night Tree Burning Ceremony Returns**

The Village of Pleasant Prairie's historic Twelfth Night event began in 1980, continued through 1993, and resumed in 2020. The ceremony will return in 2021, with the traditional holiday tree burning bonfire.

Area communities are welcome to attend to help celebrate the Twelfth Night tradition. The 2021 ceremony is planned for January 6, starting at 6:00 p.m. at RecPlex Wruck (Beach) Pavilion, located along Park Drive on the west side of Lake Andrea in Pleasant Prairie. The Pleasant Prairie Convention and Visitors Bureau (PPCVB), Pleasant Prairie Historical Society, and Village of Pleasant Prairie are hosting the event.

The Village utilizes this historic ceremony to dispose of dried holiday trees. The preferred drop-off location to contribute a tree to the event is inside the fenced-in area along Park Drive, on Lake Andrea's west side, near the beach. The holiday tree drop-off site opens for Village residents starting December 26.

Public safety at the event is a top priority. The bonfire area will be at least 100 square feet and is subject to the Fire Chief and onsite Public Safety Personnel judgment. Community members are encouraged to wear masks, maintain social distances, and follow COVID-19 recommendations. Parking along Park Drive will be reserved for Fire and Rescue to keep safety trucks and equipment closest to the fire. Guests may park in lots on either side of the Wruck Pavilion.

The Twelfth Night Celebration is free and open to the public. The Village, Historical Society, and PPCVB look forward to seeing guests attend the event. Festivities will kick off at 6:00 p.m. with a welcome from PPCVB Executive Director Michelle Williamson. The holiday tree bonfire will start at 6:15 p.m., followed by hot chocolate outside the Wruck Pavilion. Donations for the Twelfth Night are welcome to support the Historical Society that recently finished renovations to the historic Dublin School and opened the Pleasant Prairie History Museum to the community. □

# **Holiday Tree Drop-Off Sites and Fire Safety**

The Pleasant Prairie Fire and Rescue Department would like to remind residents to get rid of trees after the holiday or when they become dry. Driedout trees are a fire danger and should not be left in the house or garage or placed outside against the home.

Listed (on the left) are six holiday tree drop-off locations available for residents from December 26 through January 31. **Only trees are accepted.** 

Please remove all wreaths, garland, lights, ornaments, tree bags, stands, and nails before placing the holiday tree inside the fenced area.



**National Fire Protection Association Facts:** 

- Holiday trees are combustible items that become increasingly flammable as they continue to dry out in your home.
- 44% of home holiday tree fires are caused by electrical problems.
- 25% of holiday tree fires are due to heat sources being too close to the tree. □

# **Winter Weather Snow Safety**



When the snow starts to fall, the Public Works Department activates its **Snow and Ice Removal Plan.** Exactly what happens under the plan depends on the amount of precipitation that has fallen, is predicted to fall, the temperature, duration of the storm, and moisture content.

Remove your vehicles from public streets when approximately **2 inches** of snow has fallen or is predicted to fall. Vehicles parked in the road not only make it more difficult to clean the streets, but it also endangers safety by forcing drivers to zigzag in and out of traffic on slippery roads. As a reminder, the Village will ticket violators.

Snow emergencies are announced on Time Warner Cable Channel 25, at *PleasantPrairieWi.gov*, by text or email through *Nixle.com*, via Twitter and Facebook, and through local television, radio, and print media.

There are also steps you, as a resident, can take to ensure that snow removal operations run safely and smoothly:

- Please avoid driving or parking on the road during heavy snowstorms. Our primary purpose is to clear streets for emergency vehicles. If you must be out, please use extreme caution and do not drive too fast for conditions, wear a seat belt, drive sober, and avoid distractions.
- 2. Use caution when you encounter a snowplow. State law requires that you stay at least 200 feet behind a working snowplow. When following a snowplow, make sure that you can see the driver's mirrors so the driver is able to see you.
- 3. **Do not shovel or blow snow into public streets.** This not only defeats the purpose of our snow plowing, but it is a violation of Village Ordinances because it causes unsafe conditions for all drivers. All shoveled or blown snow must be piled in your yard or parkway.
- 4. If you live in a portion of the Village where sidewalks have been installed, please remove snow and ice from your sidewalk within 24 hours of a snowfall. Clear snow and ice away from fire hydrants located on or near your property. Keeping hydrants clear will help save valuable time, should a fire emergency occur in your neighborhood.
- 5. The Village encourages all residents to please **assist your elderly neighbors** with snow removal tasks whenever possible.



# **History of Preservation on the Prairie**

On a winter evening in 1965, conservationists from across the State drove through a snowstorm to attend a Kenosha County board meeting. The County was voting on plans for a huge marina in Pleasant Prairie that could very well have damaged the Chiwaukee. The Chiwaukee Prairie is located in the southeastern corner of the Village. Dr. Hugh Iltis, a UW-Madison plant geographer, educator, conservationist and one of the founders of the Wisconsin branch of The Nature Conservancy, drove from Madison to voice his opposition, saying, "Your children will ask, what is a pleasant prairie? and you will have no answer—for you will have destroyed it."

Even though the private marina plans were approved, a passion was stirred by a concerned group of local citizens to join together and find a way to minimize the disturbance of this important prairie lowland and upland conservation area. The Chiwaukee Prairie is part of the last unbroken stretch of prairie of its kind in Wisconsin. Its diverse area provides wetlands, dunes, savannas and prairie habitat areas for hundreds of native plants and animals, many of which are listed as threatened or endangered. With the help of The Nature Conservancy of Wisconsin, this citizen's group was able to buy a small strip of land which made it impossible to build a road leading east to the marina from Sheridan Road. The bulk of the prairie land was temporarily preserved, and the private interests of the marina proceeded. This citizens' group plus a number of private and public entities continued land acquisition to protect the prairie.

#### **Local Preservation Fund is Formed**

In 1985, Donna Peterson and Joan Rohan founded the Chiwaukee Prairie Preservation Fund, Inc., a 501(c)(3) non-

profit. This local citizen group has been raising money and slowly purchasing more property in the Prairie. Today the Preservation Fund continues its mission to acquire, restore, preserve and manage prairie lands in the Chiwaukee Prairie and Carol Beach area.
