our community were professionally rewarding and made being Administrator of

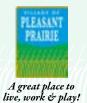

HARIBO Selects Pleasant Prairie as Location of First U.S. Manufacturing Facility

The Village of Pleasant Prairie is honored to confirm that German confectioner HARIBO has selected Pleasant Prairie as the future location of its first U.S. manufacturing facility. HARIBO will become the first tenant in the recently proposed Prairie Highlands Corporate Park at the northwest corner of County Highway Q and I-94. Planning for the HARIBO U.S. manufacturing facility is now underway, with the Village planning to install necessary infrastructure during 2017. HARIBO anticipates construction of the manufacturing facility to begin during 2018 with commencement of production and distribution during 2020.

Village President John Steinbrink Sr. commented, "The Village is incredibly pleased to welcome HARIBO to southeastern Wisconsin! HARIBO is a strong family company with a rich history of creating high quality confections dating back to 1920. I'm confident that HARIBO will find the regional business community to be a dynamic asset as it continues to grow by making children and adults happy with their amazing products."

HARIBO is a third generation family company based in the City of Bonn, Germany. The confectionary company is best known for its gummi candies, with its GOLD-BEARS® being the number one selling gummi-bear in America. HARIBO first opened a U.S. sales office for its products in 1982. HARIBO of America, Inc. is headquartered in Rosemont, Illinois.

Pleasant Prairie recently announced plans to purchase approximately 458 acres of land adjacent to I-94 to enable



its development as a new corporate park. The Village will allocate funds from its current Tax Incremental District (TID) #2 towards the purchase of the land. Plans to retire TID #2 by 2023 remain firm; its retirement will return nearly \$681,259,800 to the assessment roll, providing tax support to Village taxpayers and others. The Village is proposing to create a TID #5 to enable the development of the new corporate park. Current estimates place the value of TID #5 at \$307,308,400 once it has reached maturity. See page five for updates related to TID #2 and TID #5.

Village President Steinbrink added, "This site is well suited to support HARIBO's continued growth, and they're just the type of high quality employer the Village envisioned for this location. We'd like to thank them very much for selecting Pleasant Prairie and the state of Wisconsin." Steinbrink added, "The Village would also like to thank our economic development partners — Governor Scott Walker, Wisconsin Economic Development Corporation, Milwaukee 7, Kenosha Area Business Alliance and Kenosha County — for their roles in bringing HARIBO to southeastern Wisconsin. Our community has a great team contributing to our region's well-being and quality of life."

### **Service Line Warranties of America**

In June 2016, the Village Board authorized a three-year agreement with Service Line Warranties of America (SLWA). SLWA administers the National League of Cities Service Line Warranty Program. The program offers residential property owners a warranty that can help pay for unexpected repairs to water or sewer line laterals that connect their property to municipally owned water and sewer mains. The most common materials used in water service lines are galvanized steel, copper and PVC. Homeowners with copper or PVC water lines may not need warranty services. Those with older, galvanized steel may wish to consider warranty services. The most common materials

used in sewer service lines are clay, cast iron, and PVC. Homeowners with PVC may not need warranty services. Those with clay or cast iron may wish to consider warranty services. Homeowners can generally tell what type of water or sewer lateral they have based on the stubs in your basement where the water and sewer connect. If you have clay, cast iron, PVC, galvanized steel or copper connections in your basement, your laterals are likely made of the same material.

Participation in the warranty program is strictly voluntary. The Village has granted SLWA permission to use the Village name and logo on their mailings during the three-year agreement, so that residents can distinguish the program from other private service line insurance solicitations. However, SLWA is the administrator of the program, and no public funds are used to promote it. The program has been designed for municipal governments and can help ensure that responsible contractors are working on private water or sewer service line repairs. The Village, however, cannot make a determination as to whether individual homeowners should purchase a warranty through SLWA.



The public right of way is the area 15 feet behind the curb in subdivisions and approximately five feet behind the ditch in rural areas (the amount of right of way will vary, based on the different types of road profiles throughout the Village). Homeowners are responsible for repairing any portion of the water or sewer service lines that rest inside of the private property line leading to their home. The Village is responsible for repairing any water or sewer service lines inside of the right of way, along with any other public water or sewer infrastructure.

In recent years, residents have contacted the Village regarding mailings they have received from companies selling private water line insurance. The Village had encouraged residents to research these companies and their offers through the Better Business Bureau and the Wisconsin Department of Agriculture, Trade, and Consumer Protection. The Village entered the agreement with SLWA in order to help residents identify an affordable and reputable option for service line warranties and to ensure that responsible local contractors are working on the private service line repairs. # Conceptual Plan Approved for the Cottages at Village Green Heights



The rendering above represents one of six model styles that have been proposed as part of the Cottages at Village Green Heights.

On Monday, March 27, the Pleasant Prairie Plan Commission considered and approved a Conceptual Plan for the development of 72 condominium units on vacant property north of Main Street at 47<sup>th</sup> Avenue. Doug Stanich is proposing to construct 38 single-unit condominiums and 17 two-unit condominiums. The development has been named the Cottages at Village Green Heights.

The vacant property had formerly been referred to as Village Green Heights Townhomes North. The preliminary plat for the property, approved in March of 2003, had called for the development of 100 total condominium units comprised of 50 two-unit buildings. The vacant land is adjacent to the Village Green Heights and Village Green Heights Addition #1 single family subdivisions, in which most of the lots have been developed.

The Conceptual Plan approved on March 27, 2017 is consistent with all previous approvals, with the exception of the reduction of the number of units from 100 to 72. The development will include four ranch models ranging in size from 1,460 to 1,830 square feet and two two-story, Cape Cod style models ranging in size from 1,900 to 2,200 square feet. Units are proposed to have two or three bedrooms, two or two and a half bathrooms, full basements, two-car garages, and covered porches. The site will be fully landscaped with irrigation installed.

The developer anticipates beginning construction of required public improvements during late summer of 2017. Construction of the full development is expected to be completed during 2020 or 2021. The developer will be seeking additional approvals for the project in the coming months.  $\Box$ 

# **2017 Road Paving and Maintenance Projects**Work Expected to Begin During May

During March, Village staff solicited bids for road maintenance and paving projects proposed as part of Pleasant Prairie's 2017 budget. On Monday, April 3, the Village Board approved a contract with Payne & Dolan, Inc. in the amount of \$1,620,183.13 to complete thirteen paving projects throughout the Village.

Two-inch overlays will be completed: on River Road; on 42<sup>nd</sup> Avenue, north of 85<sup>th</sup> Street; on 116<sup>th</sup> Street, east of 4<sup>th</sup> Avenue; and at the 93<sup>rd</sup> Street Booster Station.

Asphalt will be pulverized and re-laid: in the Pleasant Prairie portion of the Cooper Road Drainage Basin, between Cooper Road and 60<sup>th</sup> Avenue and between 80<sup>th</sup> and 85<sup>th</sup> Streets; on Bain Station Road, between Highway C and 104<sup>th</sup> Avenue (including 103<sup>rd</sup> Avenue); and in the area of Becker Park (76<sup>th</sup> Street). As part of the Becker Park paving, 48<sup>th</sup>, 49<sup>th</sup> and 50<sup>th</sup> Avenues will also receive a two-inch mill and overlay.



Work on the 2017 paving projects is expected to begin in May and to be complete near the end of September. Schedules will be weather dependent.

The projects will be funded through Pleasant Prairie's general fund budget and related enterprise fund budgets. The Village will also receive \$52,369 through Wisconsin's Local Roads Improvement Program. # **County Hosting a Public Involvement Meeting Regarding Improvements at County Highway H and Bain Station Road**

#### A message on behalf of Kenosha County...

The Kenosha County Department of Public Works is announcing a public involvement meeting to discuss the reconstruction of the County H (88<sup>th</sup> Avenue) and Bain Station Road intersection in Pleasant Prairie. The existing 4-way stop intersection will be reconstructed as a roundabout.

The meeting is scheduled from 4:00 p.m. to 6:00 p.m. on Thursday, May 4, 2017 at the Village of Pleasant Prairie Auditorium in the Village Hall building, 9915 39<sup>th</sup> Avenue, Pleasant Prairie, WI 53158.

The intent of this public involvement meeting is to present the planned improvements, to show the planned detour route and construction schedule, and receive input from interested persons. Exhibits will be on display showing the planned roundabout layout and proposed detour route around the

construction zone. These exhibits will be available for review and comment.

The public is encouraged to attend the meeting, provide input and ask questions concerning this project. Representatives from Kenosha County Department of Public Works and R. A. Smith National (project Consulting Engineer) will be available to discuss the project and answer questions. Right-of-way acquisition and temporary grading easements are required to construct the project. Construction is tentatively scheduled to begin in July 2017.

# **Planning to Create New Corporate Park Proceeds**

# Work on TIDs #2 and #5 Moves Forward with Updated Financial Projections

During late February, the Village of Pleasant Prairie announced its intent to purchase land at the northwest corner of County Highway Q and I-94 to facilitate the creation of a future corporate park with a focus on manufacturing, office and commercial uses. On Monday, April 3, the Pleasant Prairie Plan Commission considered and approved two resolutions related to two separate Tax Incremental Districts (TIDs) that will help make the new corporate park possible.

On Monday, April 17, the Village Board considered and approved two similar resolutions with updated financial projections that will keep the project moving forward.

The Village has proposed a sixth amendment to the project plan for its existing TID #2. TID #2 Amendment #6 will: provide funds to purchase the land that will become Prairie Highlands Corporate Park; fund a portion of infrastructure improvements (roadways, storm sewers, sanitary sewers, water, grading and storm water management) within the district; and reconcile project costs to reflect actual and proposed expenditures.

The revised project expenses for the work listed in the amendment are estimated at \$54,161,071 (a decrease from the \$55,312,946 presented at the April 3 Plan Commission meeting). These project costs are expected to be offset by \$33,302,000 of land sale proceeds, so that the increased net cost as a result of TID #2 Amendment #6 is \$20,859,071. Previous plans to retire TID #2 by 2023 remain firm, and the TID will retire on schedule. Its retirement will return nearly \$681,259,800 to the assessment roll, providing tax support to Village taxpayers and others.

The Village has proposed to create a new TID #5 that will overlap with a portion of TID #2 that is located west of I-94 between County Highways C and Q. TID #5 will provide funds to complete infrastructure improvements. Anticipated project expenses for work detailed in TID #5 are now estimated at \$54,862,500 (an increase from the \$53,280,892 presented at the April 3 Plan Commission meeting). Current estimates place the value of TID #5 at \$307,308,400 once it has reached maturity. The Village is proposing to retire TID #5 during 2033.

A Joint Review Board is expected to consider the information on May 1. If approved by the Joint Review Board, the information will be forwarded to the State Department of Revenue.

### Final Plans Approved for New Speculative Building in LakeView Corporate Park



On Monday, March 27, the Plan Commission considered and approved Final Site and Operational Plans for the construction of a 72,324 square foot speculative industrial building. The building, referred to as Zilber Industrial 1, will be constructed on approximately 4.5 acres at the northwest corner of 102<sup>nd</sup> Street and 78<sup>th</sup> Avenue. Preliminary Site and Operational Plans for the project had been approved during late November of 2016.

The speculative building will be constructed to accommodate a warehouse, distribution and/or manufacturing tenant. No tenants have yet been identified. Plans call for six dock locations (expandable to 13) on the north side of the building with two drive-in doors. The building will have a total of 71 parking spaces located on the south side of the building. Approximately 31% of the site will remain open, green space.

Automobile access to the site, for employees and visitors, will be available from 102<sup>nd</sup> Street and will be a shared access point with a property owner to the west. Trucks will access the site from a separate drive from 78<sup>th</sup> Avenue. Zilber intends to begin construction of the new speculative building this spring with completion anticipated during late fall of 2017.

# Citizens Group to Purchase Body Cameras for Pleasant Prairie Police Officers



The Pleasant Prairie Police Department recently completed field testing of body cameras, a project the department began in July of 2016. Throughout the field testing process, Village officers wore and utilized two body camera models. The department has selected the Safariland VIEVU body camera as the preferred model.

With the financial assistance of a newly formed citizens group, the Pleasant Prairie Police Officer Appreciation Association Inc., the department will purchase 31 body camera units, which is enough to supply each officer with a camera system.

As a part of the testing process, the department drafted a policy for the use of the new cameras. That policy will be available for public review once body cameras are placed in service by the department. Officers with the Pleasant Prairie Police Department would like to sincerely thank those who have made the purchase of the body cameras possible.
