Pleasant Prairie Police Department Launches New Community Camera Partnership Program

The Pleasant Prairie Police Department is initiating a new community crime fighting partnership with Village residents. The initiative, known as the Community Camera Partnership enables residents to let the Police Department know if they'd be willing to share video footage from home security cameras aimed outdoors should a crime or suspicious activity occur in their neighborhood.



Through a short questionnaire on the Village website, residents can log their home as a location where a camera may be able to provide assistance should a crime or suspicious activity occur. The locations will be marked on a map. If a crime is reported near one of the locations, officers would know that they could contact a resident in the area to ask them to look at their camera footage.

The department sees the partnership as a modern day extension of the Neighborhood Watch Program. Chief of Police David Smetana explained, "This is today's version of being a good neighbor. Neighbors can take this proactive step to help keep their neighborhoods safe and free of crime."

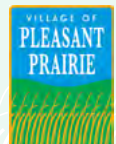
"The department hopes to achieve a two-fold benefit for the community through the partnership. We hope to solve more crime in our community more efficiently, and we hope to deter future crime from occurring." Smetana explained, "Once word of the partnership gets out, we hope people planning a crime in Pleasant Prairie think twice about being caught on camera."

During 2016, the Police Department sought community input related to the voluntary partnership through the Open Village Hall forum on the Village website. The response received was positive, and since that time, the department has been working through the technical steps in order to get the initiative up and running.

"It's important to note that all aspects of this program are completely voluntary, and that at no time would the police have any remote access to the security system," Smetana stated. "The home owner remains in complete control of their personal camera system."

Preliminary Site and Operational Plans Approved for Addition of Outpatient Surgical Wing at St. Catherine's Hospital

On Monday, February 13, the Pleasant Prairie Plan Commission considered and approved preliminary site and operational plans for the construction of an Advanced Outpatient Surgical Wing at United Hospital System's St. Catherine's Medical Center Campus. Approval of the preliminary plans will enable site grading to begin, along with the installation of early footings, foundations and underground utilities, during the spring of 2017.

Preliminary plans call for the construction of a 239,977 square foot addition adjacent to the existing hospital located at 9555 76th Street in Pleasant Prairie, Wisconsin. Plans include a first floor that will accommodate a lobby, lounge, café, courtyard, registration and waiting area, private preoperative suites, a minimum of eight surgical suites, and recovery areas.

The plans also call for a lower level to accommodate support areas, a relocated receiving dock, and a trash enclosure. Second, third and fourth floors of the addition will eventually house various outpatient services.

In 2001, United Hospital System submitted site and operational plans for the medical center campus, which included a hospital with medical offices on approximately 50



acres within the Prairie Ridge development. During 2008 a multi-story expansion of the hospital building was completed. During 2010, a medial office building was added to the campus.

United Hospital System is expected to submit final site and operational plans for the current project later this spring in order to accommodate the start of construction this year. The project is expected to be complete during 2018. Upon completion, the Advanced Outpatient Surgical Wing is expected to employ between 100 and 125 employees, in addition to those currently working from the St. Catherine's Medical Center Campus. □

Plans Approved for Binder Family Chiropractic

On February 13, the Plan Commission approved site and operational plans for Binder Family Chiropractic to renovate and occupy the interior of a vacant commercial building located on the south side of State Highway 50 at 10715 75th Street. No exterior site or building modifications, other than signage and security cameras, have been proposed.

Binder Family Chiropractic has plans to offer healthcare services from the renovated 1500 square foot building including: x-ray, chiropractic care, and massage. Hours of operation for the new facility are expected to be Monday, Tuesday and Wednesday from 8:00 a.m. until 12:00 p.m. and 2:00 p.m. until 6:30 p.m.; Thursday between 1:00 and 6:00 p.m.; and Friday between 8:00 a.m. and 3:00 p.m.



Renovations of the facility are expected to be completed at the end of April, 2017. Two full-time chiropractors, one full-time front desk assistant, and three part-time massage therapists are expected to work from the location. □

On Monday, March 6, Kenosha Area Transit will reintroduce bus service to LakeView Corporate Park. A schedule for the 35 Express route is shown above.

The 35 Express route will run: from the Kenosha Area Transit Center in downtown Kenosha south on Sheridan Road to 85th Street; west on 85th Street to Green Bay Road; south on Green Bay Road to Highway 165; and west on Highway 165 to a loop bordered by 95th Street on the north, County Highway ML on the south, and 88th and 80th Avenues on the west and east.

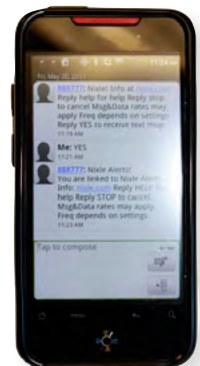
Reintroduction of the bus route to LakeView Corporate Park from the City of Kenosha will enable those living in the City who may not have access to other forms of transportation to travel to and from employment opportunities in LakeView Corporate Park.

Dispose of Unwanted Medications Around the Clock at the Pleasant Prairie Police Department



In an effort to prevent accidental poisonings, prescription drug abuse, and pollution of our local waterways, the Pleasant Prairie Police Department (in cooperation with the Kenosha County Division of Health Services and other area law enforcement agencies) offers a permanent medication collection site.

The medication drop box is located in the lobby of the Pleasant Prairie Police Department at **8600 Green Bay Road** and is available 24 hours per day, seven days per week. Through the drop box, you can dispose

of unused, unwanted, and expired medications in a safe and environmentally sound manner, free-of-charge. Medication should be kept in its original container with the name of the medication visible. Cross off any personal information on the container; place it in a bag; and dispose of it in the Medication Drop Box. The medication handlers thank you for following these guidelines.

Items that CAN be placed in the box include: prescription medications, ointments, over the counter medications, creams, and pet medications.

Items that CANNOT be placed in the box include: needles, sharps, and syringes, inhalers, sprays, liquids (like cough medicine), injectables, intravenous solutions, illegal drugs, and biohazardous materials.

Residential Street Lights Your Help is Needed

Before the warm weather workload peaks, Village staff is requesting the help of residents to report non-working street lights in residential neighborhoods. A street light is considered non-working when it is flickering continually, not lighting in the dark, or if the light is on during daylight hours.

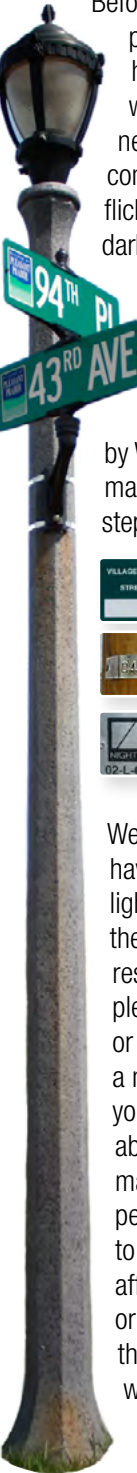
Who To Contact

Because some street lights in the Village are maintained by We Energies and some are maintained by Village staff, the first step is determining who to contact

for repair. The Village maintains most street lights in residential neighborhoods. Village street lights should have a numbered sticker

affixed to the base of the light pole (top image at left).

We Energies street lights should have a numbered metal tag on the light pole (two bottom images at the left). To notify the Village when a residential street light needs repair, please email at pw@plprairie.com or call **925.6700**. If you're unsure if a non-working light is a Village light, you can also contact the number above. Staff will refer to a street light map and notify the appropriate repair personnel. When you call, we will need to know the number from the sticker affixed to the pole, or the intersection or address of the home nearest to the light pole. To notify **We Energies** when a street light needs repair, please call **800-662-4797** or visit www.we-energies.com and select **Report a streetlight out** at



the bottom of the page. Village staff thanks you for your help. □

Residential Recycling Center Opens for On-Season Hours on Saturday, March 25

Pleasant Prairie operates a Residential Recycling Center for Village residents. The center will be open for on-season hours between March 25 and December 2, weather permitting. NEW...during 2017, the Residential Recycling Center will remain open on Saturdays between 7:00 a.m. and 4:00 p.m. throughout the off-season (December through March).

The center is easy to use, with convenient drop-off hours and options and free items for Village residents - compost, wood chips and mulch. Drop-off options can help you work around times when you need more flexibility with your disposal options, like dropping off your garbage and recycling before you leave for a vacation. **Please note, the Residential Recycling Center is closed on the first Wednesday of each month in order to accommodate safe grinding operations.*

The Residential Recycling Center is located at **8000 128th Street**. When using the center, please be prepared to provide proof of residence in Pleasant Prairie. If you frequent the site, for your convenience, you can request a compost sticker for your automobile window.

Garden waste, grass clippings, leaves, tree trimmings and other yard waste will be accepted in cans, bags or from vehicles trunks/beds.

FREE Accepted Materials/Items

- One cubic yard of dirt
- One cubic yard of concrete
- One cubic yard of gravel
- One cubic yard of asphalt
- One cubic yard of metal
- Recycling and/or garbage

(One cubic yard is 3' wide, by 3' long, by 3' tall.)

Additional Items Accepted For a Fee

To accommodate those times when collection at your home is not convenient, you will now be able to drop select items at the site during the hours of operation listed to the left. A fee is charged to cover the cost of handling and disposing of your item.

- Miscellaneous electronics* (\$5 each)
- Tires (\$5 each)

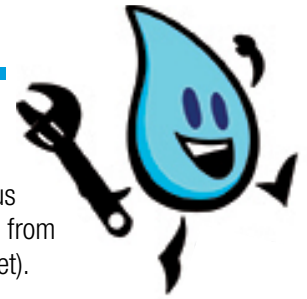

Ready, Set, Go! Grant Awarded to the Kenosha Area Convention and Visitor's Bureau for the 2017 Ice Skating Institute Synchronized Championships at RecPlex this March

Fix a Leak Week Begins March 20...

The Environmental Protection Agency celebrates Fix a Leak Week each March to remind Americans to check their household fixtures and irrigation systems for leaks. Household leaks can waste more than 1 trillion gallons of water annually nationwide. That's equal to the annual household water use of more than 11 million homes. A one gallon per minute leak can add up to more than half a million gallons per year. Being handy around the house doesn't have to be difficult. Common types of leaks found in the home include worn toilet flappers, dripping faucets, and other leaking valves. These types of leaks are often easily correctable, requiring only a few tools and hardware that can pay for themselves in water savings.



12,000 gallons per month, there are serious leaks inside your home from a fixture (such as a toilet).

Check your water meter before and after a two-hour period when no water is being used. If the meter changes at all, you probably have a leak at a toilet. **Identify toilet leaks** by placing a drop of food coloring in the toilet tank. If any color shows up in the bowl after 10 minutes, you have a leak. (Be sure to flush immediately after the experiment to avoid staining the tank.) **Examine faucet gaskets and pipe fittings** for any water on the outside of the pipe to check for surface leaks.

To check for leaks in your home, you first need to determine whether or not you're wasting water. If you are, then you'll need to identify the source of the leak.

Take a look at your water usage during a colder month, such as January or February. If a family of four exceeds
