

OFFICIAL NOTICE TO BIDDERS

CTH H WATER MAIN IMPROVEMENTS VILLAGE OF PLEASANT PRAIRIE KENOSHA COUNTY, WISCONSIN

OWNER: The Village of Pleasant Prairie hereby gives notice that Bids will be received for the construction of the CTH H Water Main Improvements project.

The Project consists of one prime Contract and generally consists of the following: 1,440 LF of 16" PVC water main, 125 LF of 12" PVC water main, 125 LF of 8" PVC water main, 75 LF of 6" PVC water main, 550 LF of 1.5" water service, 215 LF of boring 16" water main, 650 LF of boring 1.5" water service, 11,050 LF of abandoning water main, 4 EA of hydrants, 4 EA of 5" gate valve, 4 EA of 8" gate valve, 5 EA of 12" butterfly valve, 14 EA of 16" butterfly valve, erosion control, and restoration.

All Contractors shall comply with the "Contractor Qualification Ordinance of the Village of Pleasant Prairie" requiring pre-qualification of Contractors prior to performing work on this Contract. All Contractor pre-qualifications must be complete and submitted 5 days prior to bid opening date/time. Approved pre-qualifications will be posted prior to bid opening. All Sub-contractors utilized for this Contract must be identified in the bid documents under "LIST OF SUBCONTRACTORS AND SUPPLIERS" and all Sub-contractors must be pre-qualified prior to award of this Contract. TIME AND PLACE OF BID OPENING: Bids will be accepted until 2:00 P.M., Local Time, on Thursday, February 1, 2024. The Owner will ONLY be receiving and accepting bids for the project via the online electronic bid service through QuestCDN.com. To access the electronic bid form, download the project documents and go to the online bidding section within the website.

BIDDING DOCUMENTS: Contract Documents and the Construction Plans may be obtained ONLY from QuestCDN.com. Bid documents may be examined at the Village Hall, 9915 39th Avenue, Pleasant Prairie, Wisconsin, 53158 or downloaded under login after January 18, 2024, for a non-refundable fee of \$40.00. All submitted Bidding Documents shall be original copies obtained directly from QuestCDN. Paper copies of the Bid Documents will not be made available.

LEGAL PROVISIONS: The Contract letting shall be subject to the provisions of Sections 61.54, 61.55, 66.0901, and 66.0903 of the Wisconsin Statutes.

BID SECURITY: Bid Security in the amount of not less than 5% nor more than 10% of the Bid shall accompany each Bid in accordance with the Instructions to Bidders. Acceptable Bid Security shall be Bid Bond, Certified Check, Cashier's Check, or Money Order.

CONTRACT SECURITY: The Bidder to whom the Contract is awarded shall furnish a Performance Bond and Payment Bond each in the amount equal to the Contract Price.

BID REJECTION / ACCEPTANCE: Owner reserves the right to reject any and all Bids, waive informalities in bidding or accept the Bid or Bids, which best serve the interest of Owner.

BID WITHDRAWAL: No Bid shall be withdrawn for a period of 40 days after the opening of the Bids without the consent of the Owner.
