

NOTICE OF PUBLIC HEARING ON SPECIAL ASSESSMENTS 26TH AVENUE WATER MAIN EXTENSION

PLEASE TAKE NOTICE that the Village Board of the Village of Pleasant Prairie, Kenosha County, Wisconsin has adopted a Preliminary Resolution (#21-02) declaring its intention to exercise its police power to levy special assessments pursuant to §66.0703, Wis. Stats., upon property within the proposed assessment district which consists of 12002 and 12015 26th Avenue, in the Village of Pleasant Prairie. The project generally consists of a 8-inch water main extension and appurtenances along 26th Avenue commencing approximately 135-feet north of the south property line of 12002 26th Avenue and terminating at the south property line of 12002 26th Avenue.



PLEASE TAKE FURTHER NOTICE that a public hearing is scheduled for **February 15, 2021, at 5:00 p.m.** All interested persons, their agents or attorneys, concerning matters contained in the preliminary resolution authorizing the assessments will be heard. The hearing will be conducted virtually utilizing a web-based application called GoToWebinar. This will be the last meeting held concerning the project's special assessment. All objections will be considered and thereafter the amount of the assessments will be determined.

There will be an opportunity at the public hearing for public comment. To register for the virtual meeting, go to PleasantPrairieWi.gov/GoTo. Once registered, login instructions on how to access the web-based virtual meeting scheduled for February 15, 2021 will be emailed. Users that utilize this method will have an opportunity to raise a virtual hand to speak during the public comment section. People can also call in by phone to listen without comments at (415) 655.0060 and use access code #150-226-663. Written comments can also be submitted via e-mail to engineering@plprairie.com, mailed or hand delivered to the Office of the Village Engineer, Pleasant Prairie Village Hall at 9915 39th Avenue. Written comments received before noon on February 15, 2021, will be distributed to the Village Board and considered at the public hearing. The last option is to attend in-person at the Village Hall Auditorium. Please note that Village Board members will not be in-person and will be participating in the public hearing virtually. In-person attendance is not recommended due COVID-19 safety concerns. Any person wishing to attend in-person must RSVP by calling (262) 925.6729.
